CONSENT TO ETI POLICIES, AND AGREEMENT FOR WAIVER, RELEASE OF LIABILITY, AND ASSUMPTION OF RISK RE: COVID-19

COVID-19 is contagious and is believed to spread from many different means including, but not limited to, aerosolized micro-droplets, person-to-person contact, contact with contaminated surfaces, and transmission from hands to face. COVID-19 can be fatal. Some individuals that become infected with COVID-19 suffer long-term and permanent health conditions and disabilities. Participation in education, training, examinations, tours, and other activities at the Electrical Training Institute, Inc. ("ETI") involves the risk of exposure to COVID-19, which may lead to serious and permanent bodily injury, disability or death. ETI has implemented measures intended to reduce the spread of COVID-19 based on currently available medical information; however, the ETI cannot and does not guarantee, represent, or warrant that you will not contract COVID-19 while at the ETI. By signing below, you voluntarily assume all risks contracting COVID-19 at the ETI, including but not limited to serious and permanent bodily injury, disability, or death that you may sustain as a result of being present at the ETI during the COVID-19 pandemic.

By signing below, you consent to the ETI's policies as follows:

- ETI will check your temperature before entering the premises. If you have a temperature, you will not be allowed to enter the premises.
- ETI will require you to answer certain screening questions before entering the premises. You agree inform the ETI if you have been diagnosed with COVID-19. You agree to inform the ETI if you have had any of the symptoms of COVID-19 within the last 14 days including fever, chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, or diarrhea. You agree to notify the ETI if any immediate family members or others you have had close contact with have tested positive for COVID-19 or may reasonably be considered ill with the virus. You agree to notify the ETI if you have failed to follow any state or international travel restrictions including, but not limited to, those that require self-quarantining or self-isolation under various conditions.
- ETI requires you to use the available hand sanitizer upon entering the premises or immediately going to the sink and washing your hands with soap and water.

- ETI requires you to make every effort to maintain social distancing by staying at least six feet away from other persons at the ETI, and by obeying the signs and markers for social distancing.
- ETI requires you to wear a cloth mask or other appropriate face covering while at the ETI, including in common areas where others are present. You need not wear the face covering when alone in a private office, classroom, or walled cubicle with a sold partition that exceeds the height of the employee when standing. You may use your own cloth or approved face covering or you may request one from the ETI if you do not have one.

By signing below, you acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that you may be exposed to or infected by COVID-19 at the ETI and that such exposure or infection may result in personal injury, illness, permanent disability, and death. You understand that the risk of becoming exposed to or infected by COVID-19 at the ETI may result from the actions, omissions, or negligence of yourself and other third parties and entities, including, but not limited to, the Electrical Training Institute, Inc.; the Los Angeles County Electrical Educational and Training Trust Fund; 6023 South Garfield Avenue, Inc.; and all of their trustees, directors, officers, employees, agents, and representatives (collectively, the "Releasees").

By signing this agreement, you voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to yourself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense of any kind, that you may experience or incur in connection with your participation in any activities at the ETI ("Claims"). On your behalf, and on behalf of your minor children, you hereby release, covenant not to sue, discharge, and hold harmless the Releasees of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. You understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Releasees, whether a COVID-19 infection occurs before, during, or after participation in any activity at the ETI.

WITH THE ABOVE UNDERSTANDING YOU HEREBY RELEASE AND HOLD HARMLESS THE RELEASEES FROM ANY AND ALL LIABILITY OR RESPONSIBILITY, NEGLIGENCE, CAUSES OF ACTION, CLAIMS, DEMANDS AND DAMAGES OF EVERY KIND WHICH MAY ARISE OUT OF YOUR PARTICIPATION IN ANY ACTIVITIES AT ETI DURING THE COVID-19 PANDEMIC.
